1. have been the undivided co-owner of an immovable or co-occupant of a business establishment situated on the territory of the municipality or, as the case may be, in the sector concerned by the referendum for at least 12 months on

and, as of that date, not have been convicted, in the last five years of an offence that is a corrupt electoral practice.

2. have been designated by means of a power of attorney signed by the majority of the co-owners or co-occupants who are qualified voters on

(last day set by the clerk or secretary-treasurer to present an application before the board

A model application for entry, power of attorney or resolution form is available at the office of the clerk or of the secretary-treasurer. Applications for entry, powers of attorney and resolutions take effect upon their receipt and remain valid until such time as they are withdrawn or replaced.
